## Grant requests \$10,000 and under must be submitted online by 11:59 pm, February 4, 2019. Grant requests over \$10,000 must be submitted online by 11:59 pm, February 14, 2019.

In order to be eligible to receive a grant from the Foundation, an organization must hold a 501 (c) (3) nonprofit status or be a governmental organization. All grants must benefit the residents and communities within the defined BHWF geographic boundaries. **Individuals are not eligible to apply**. If your organization's office is outside of the Berwick Health and Wellness service area, you may still apply if you will be serving residents within the Fund's service area. Prior to attending a grant workshop, you may begin preparing documents in electronic form that will be required to upload online via the web-based grant application process. Documents include but are not limited to the following:

- 2. Most recent 990
- 3. Current Board of Directors list
- 4. Project Budget for specific grant request

An additional grant opportunity from the BHWF will be announced in February 2019. The BHWF Innovation & Collaboration Grantround will award \$50,000 to one applicant and will be open February-May 2019.
