COVID-19 County Relief - Columbia and Montour County Nonprofit Organizations

The Community Foundation has partnered with Columbia and Montour Counties to administer COVID-19 County Relief Block Grant funding for nonprofit organizations. This grant is designed to provide relief for costs incurred during the period from March 1, 2020, through December 30, 2020.

Eligibility Requirements:

- Any nonprofit organization (501c3 or 501c19) serving Columbia and/or Montour County
- Funding requests should primarily focus on meeting the organization's needs due to loss of revenue, closures, event/fundraising cancellations, as well as other challenges.

Grant requests up to \$15,000 are currently being accepted.

Grant requests must be submitted online by 11:59 pm on Friday, September 11, 2020.
