- Total employees must be less than 100 OR an entity primarily engaged in the Tourism industry
- Business must be based in Columbia County, PA
- Net Profit for the period of March 1 - June 30, 2020 must be less than Net Profit for the period of March 1- June 30, 2019
- Must not owe federal, state or local taxes
- Must not be subject to any criminal justice process, as per the question in the application

Required Documentation:

- Most recently filed federal tax return
- Entity documents including DBA or FBN certificate and proof of ownership
- Business License (if sole proprietor)
- Government Issued ID
- Evidence of fixed costs including: mortgage/rent/lease payments, utility costs, license fees, property tax bills, property and liability insurance bills, attest to any inventory lost.
