MUSICIANS SUPPORT COMMUNITY PRIDE Grant Story

The Danville Community Band has been sharing music with the local community since 1969. Comprised of about 40 members from Danville and surrounding communities, the band was designed as a place for area musicians to meet, grow, and express themselves—while generating interest in events and projects that benefit the feeling of community in Danville. Performances include playing concerts at local church fundraisers, entertaining residents at area nursing and assisted living facilities, marching in community parades, and participating in local festivals and concert series.

Through its long and seasoned history in Danville, the band's commitment to supporting community and creating welcoming spaces for musicians and audiences has remained the same. With a recent grant from Community Giving Foundation: Danville, the band plans to replace outdated and damaged percussion instruments and equipment that have served the band well for many years. With newer—and more efficient—instruments and equipment, the band looks forward to creating an even better experience as it entertains local audiences for years to come.

"The executive board of the Danville Community Band greatly appreciates the funds that we received from the Foundation. The band has lost revenue over the past several years due to the pandemic and a reduction in engagements.
